The National Safety Code as applied in Alberta applies to commercial vehicles registered for 11,794 kilograms or more for provincially regulated carriers and applies to vehicles registered for 4500 kilograms or more for federally regulated carriers. Changes have been made to the Traffic Safety Act and to several other regulations including trip inspections and vehicle equipment maintenance regulations. This educational seminar, for existing as well as carriers new to the program, will outline the National Safety Code requirements and regulations as applied in Alberta.

Federal Hours of Service legislation changed January 1, 2007 for federally regulated Carriers for National Safety Code vehicles registered 4,500 kgs or greater.
